



The Managing Trustee shall be Mr.S.Perumal. The Managing Trustee shall have the power togappoint Temporary Trustees on such terms and conditions as they may desire from time to time. The temporary trustee is three years from the date of appointment. The temporary trustees shall be re-appointed by the Managing Trustee. Any vacancy in the permanent trustees or in the Managing trustee shall be filled up by the Permanent trustees. The non appointment of any permanent trustee in the vacancy shall not invalidate the Trust or the things done by the Trustee or Trustees. No remuneration is payable to Trustees.

POWER AND DUTIES OF TRUSTEES:

 All the properties, funds and assets of the trust shall vest in the Trustees and they shall be in complete management of the affairs of the Trust.

2. The Managing Trustee of the Trust shall have the power of administration, employment, removal of employees etc. A secretary Treasurer and also other members to form a Managing Committee, may be appointed by the Managing Trustee to look after the day to day administration of the trust under the supervision

and control of the Managing Trustee of the Trust.

Kalaimagal Vidhyalaya School Pandhalkudi - 626 113 regulate their meetings, as they think fit. The Managing Trustee shall summon meetings of the members of the said committee. The Managing Trustee shall be entitled to exercise one additional casting vote in the event of equity of votes.

4. The Trustees shall have power to augment the funds of the Trust from any source by accepting donations, voluntary contributions of any kind if they think such acceptance is in the interest of the Trust.

5. Without prejudice to the above such general powers the trustees shall have powers:

a) To purchase, take on lease land and buildings, equipments, machinery, tools etc., and maintain and keep up lands building, equipment and materials and to sell, mortgage or dispose of all or any of the same as the Trustee/s may think fit and alienation of immovable properties of the trust can be done only with the prior approval of the Director of Income tax granting exemptions. But as on date the trust do not hold any immovable properties in its name.

b) To execute, become party to, sign acknowledge, perfect and register all deeds,

agreements and to give effectual discharge on behalf of the Trust.

c) To initiate, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claim or disputes its officers of employees concerning the affairs of the trust and to sign and verify Vakalaths, Plaints, Statements, Execution, Petitions, Affidavits and other proceedings.

d) To open and close accounts with Banks, to operate upon any such accounts to pay and draw money from such accounts and otherwise deal with the same and the powers in this behalf may be exercised by the Managing Trustee or by any other Trustee/s empowered by a resolution of the Trustee/s in a meeting held under the Presidentship of the Managing Trustee.

e) To insure and keep insured, if deemed expedient, all or any of the buildings and

other assets of the Trust.

f) To carry out transactions as they consider expedient in the interest of the Trust and to make all such arrangements and do such acts and things on behalf of the Trust as may be usual, necessary desirable or expedient for the Management of the affairs of the Trust or in carrying out its objects.

g) To invest the funds of the Trust only in the investments authorized under the provisions of the Income Tax Act and other Direct Tax Acts which will enable the

Trust to avail the exemption available thereunder.

h) The Trustees shall at all times stand indemnified in respect of any acts that may have been done bonafide by them in respect of matters relating to the Trust.

i) It shall be obligatory for the Trustees to make investments only accordance with

modes prescribed under section 20 of the Indian Trust Act.

j) To invest money of the Trust not immediately required for its purposes in or upon such investments securities or property as may be thought fit subject nevertheless, that such investment be in accordance with the provision of the Section 11(5) read with section 13(1)(d) of the Income Tax Act 1961 as amended from time to time.

k) The Trustees are authorized to borrow moneys for the purpose of the Trust from Banks, financial institutions and others with or without security and in respect of any other assets both movable and immovable belonging to the Trustees security and execute under the need of agreement or deed of mortgage for the purpose of offerings the assets of the Trust as security in respect of such borrowings.

assets of the trust in any immovable properties as may be found necessary from time to time and have the right to sell, lease, mortgage or dispose of such assets and immovable properties as may be found necessary in this behalf on approval of the trust Board and any such documents/contracts shall be signed by the Managing Trustee.

m) The Trustee or Trustees are authorized to acquire by purchase or by lease, or assignment from private companies, individual or government land, buildings, Agricultural lands and other properties for the purpose of carrying out the objects of the Trust. The Trustee or Trustees are authorized to construct on own land or leased or assigned land, superstructure for the purpose of the object of the Trust and for the said purpose all the documents shall be signed by the Managing Trustee.

n) To delegate by Powers of Attorney or by a resolution passed in this behalf or otherwise any of the powers herein above specified, to any Trustee or Trustees or any other person or persons for effectively and smoothly carrying out the objects

of the trust and for proper administration of the Trust.

o) The Trustees are entitled to make rules for the purposes of the objects of the Trust, but such rules shall not be against the objects of the Trust as stated above. Any amendment to any clause of this Trust deed shall be carried out only with the approval of the Trustees, subject to the provisions of law.

p) The Trust is entitled to collect fees for the purpose of the objects of the Trust.

q) To collect donations, gifts in cash or kind from registered bodies or firms, limited company or from Govt. either by aids to trust or getting lands by donations or by assignments or for long lease and other general public irrespective of caste, religion, sex etc., and use the same towards fulfilling aims and objects of the trust.

To raise/borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security movable or immovable as the management think fit or secure payment of with interest by

mortgage of the trust properties.

ASSETS OF THE TRUST:

Vo:

The Trust assets shall comprise of all funds received as donations whether as Corpus fund or otherwise, all income, the investment, movable and immovable properties acquired by gift, purchase, lease or otherwise and all the properties shall be held either in the name of the Trust or in the name of the Managing Trustee or two of the Trustees as the circumstances

may require in Auture 194 persyent there is no I mome value belongs to this toust ACCOUNTS:

The Managing Trustee shall maintain regular accounts of the Trust Funds and records of its available properties and shall get the same duly audited by a Chartered Accountant. The audited accounts of the Trust shall be placed before the Board of Trustees for their verification, inspection and approval. The surplus fund if not applied within the year of account shall be accumulated for any specific object of the Trust and invested in any manner authorized under the Income Tax Act for the time being. The accounting year of the Trust, shall be from the 1st of April to 31st March of the succeeding Calendar year.

Pandhalkudi - 626 113

1. There shall be framed Rules and Regulations for the conduct of the affairs of the Trust and for its administration and for carrying out the object, aims and purposes of the Trust and for the maintenance and conduct of its projects, activities and facilities. The Board of Trustees may also alter, amend or vary such Rules and Regulations from time to time as they may deem proper.

2. No amendments to check, curtail or restrict any rules framed within the Trust shall be made which may prove to be repugnant to the provisions of the sections 2(15), 11,

12, 12A and 80G of the Income Tax Act, 1961.

3. If the trustees consider that the aims, objects and purposes of the Trust will be better achieved the Income of the Trust is exempted form taxation under the provisions of the Income tax Act. An application for the purpose of obtaining the exemption under the provision of the Income Tax Act shall be made as soon as is reasonably practicable. In case any particular clause of the Instrument of trust has been inadvertently closed in language, capable of an interpretation in conflict with the relevant provisions of the Income Tax Act granting exemption, it is hereby expressly declared that such clauses shall have restricted meanings or be null and void in entirely as the case may be, in order that the relevant Income Tax Provisions will always have over riding effect the exemption prayed for being granted.

GENERAL:

1. This Trust shall be irrevocable.

2. The Trustee/s shall have power to frame from time to time Rules for the proper conduct of the affairs of the Trust and alter, named any of the powers vested in them for administration of the Trust, with the prior approval of the Director of Income Tax granting Exemptions u/s 80G of Income Tax Act.

3. The Income of the funds of the Trust shall be solely utilized towards its objects and no portion of it shall be utilized for the payment to trustees by way of profit, interest,

dividend etc.,

4. The benefit of the trust are open to all persons irrespective of Caste, Religion, Sex etc.,

No activities of the Trust shall be carried, outside India.

The Trust shall not carry on any activity with the intention of earning profit.

7. The Trustees may appoint additional trustees, as appointed trustees for efficient management to assist in the management of the trust to achieve the objects of the Trust as and when necessary.

LIABILITY OF THE TRUSTEES:

 The Trustees for the time being under these presents shall be respectively chargeable only for such moneys as they shall respectively actually received notwithstanding their respectively signing and receipt or receipts for the sake of conformity shall be answerable and accountable for only their own acts, receipts, neglects and defaults and not for those of the others or other of them, or for any bankers or other person with whom or in whose hands any trust moneys may be deposited or may come or for any loss unless the same shall happen through his, her or their own willful

2. In the event of the Trust not being able to function in fulfillment of the objects, after discharging all the liabilities, the trustees shall transfer the assets of the Trust to any Public Charitable Institution of Institutions having similar objects.


